As the Directing Attorney of Immigration, I'm keenly aware of the increased number of calls the Survivor Justice Center has been receiving from the survivors we serve. One reported being afraid to go to her health appointment for dialysis because it is located by a Home Depot. Many have shared being extremely afraid of doing simple things they've done for years—like going to work or dropping their children off at school. Several have even said they are more afraid of being kidnapped by ICE when they attend court than of having to face their abuser.

We've lost hundreds of thousands of dollars in immigration services funding, but, thanks to our dedicated supporters, we've still been able to continue, and even expand, our programs—helping us persist in building power and pushing back against these attacks.
